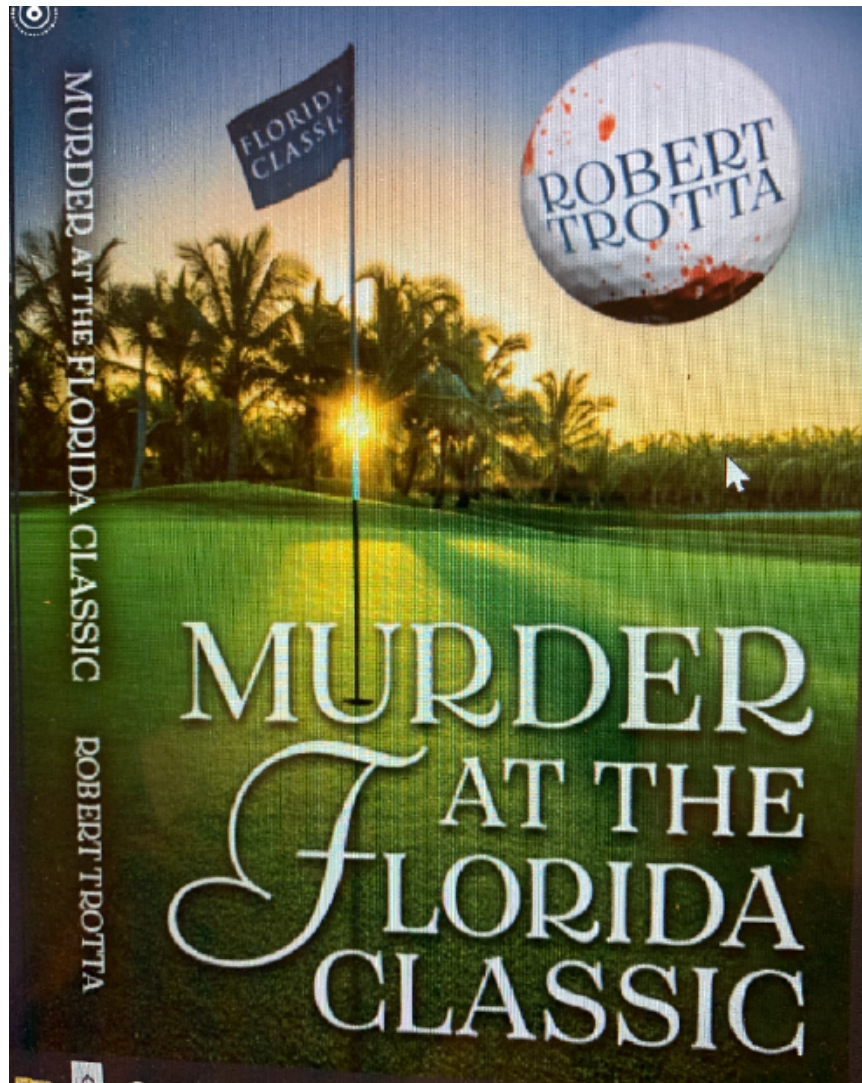
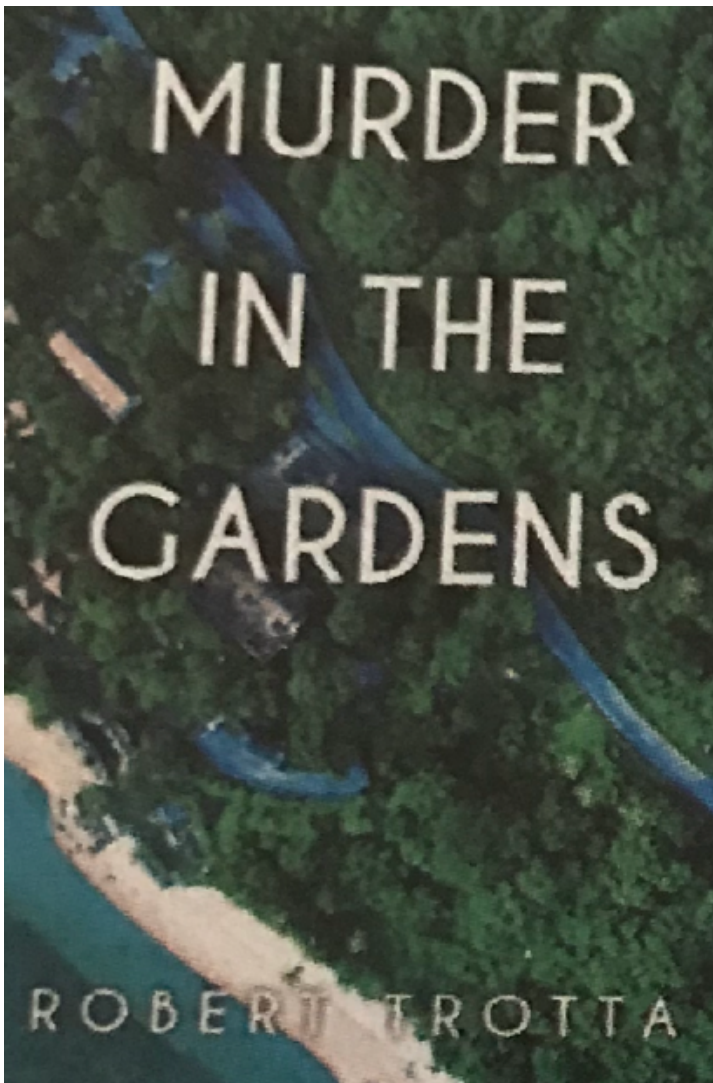

Retiree Program

In 2006, POPPA started its Retiree Program. The program began with 26 retired NYPD officers dedicated to help meet the needs of fellow retired police officers. The mental health and other unique needs of this group are often overlooked. Retired police officers can use

POPPA services for a variety of stress or mental health issues, relationship problems, substance use, or if they feel suicidal. Sometimes, retirees just need to reconnect with another person who can identify as a law enforcement peer.

For others, the changes in relationships with police peers, the identity as a police officer, the change of pace and leaving a job you loved, or starting a new career can present some difficulties in this new chapter. There are huge differences in the amount of your "free" time, the degree of structure to your day, changes in family responsibilities, and the level of social activity and potential support. Unfortunately, for many officers, the troubling events that were filed away during a career may come to the surface and the ways in which officers cope sometimes adds to the difficulty.

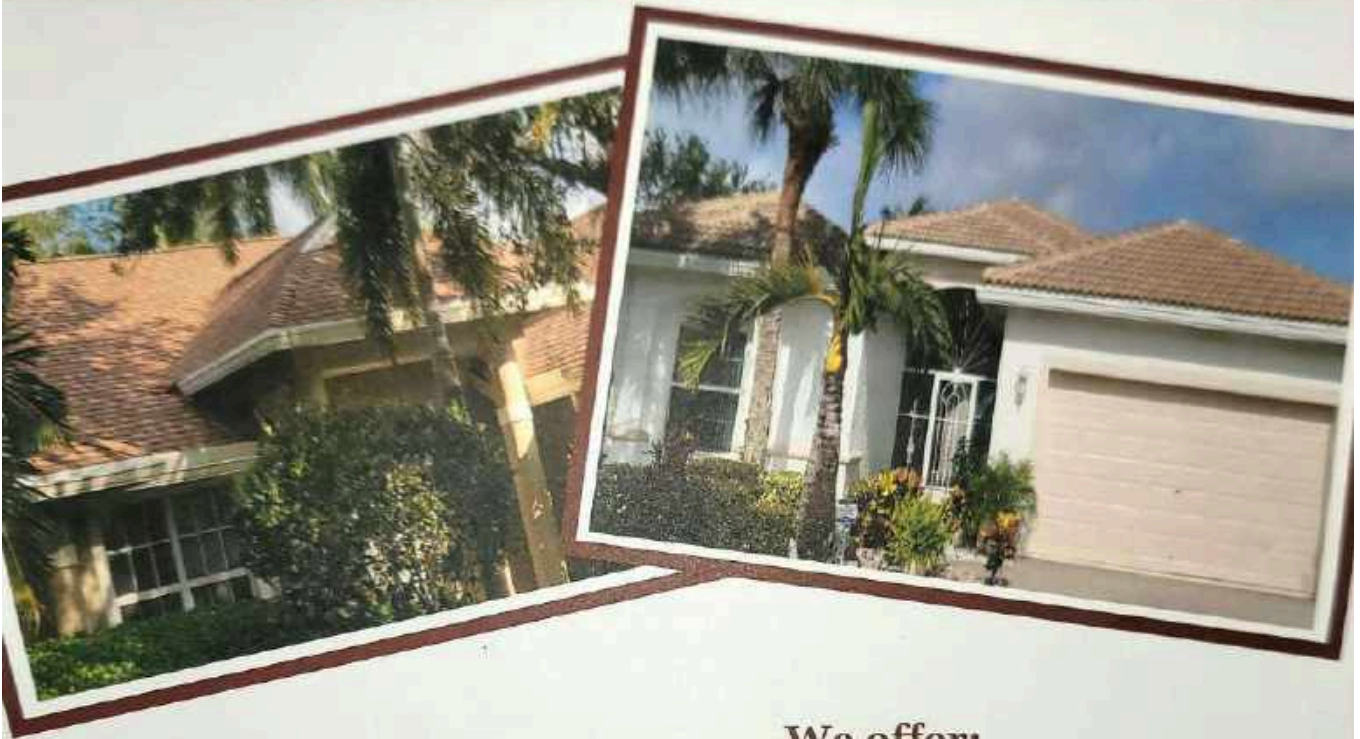

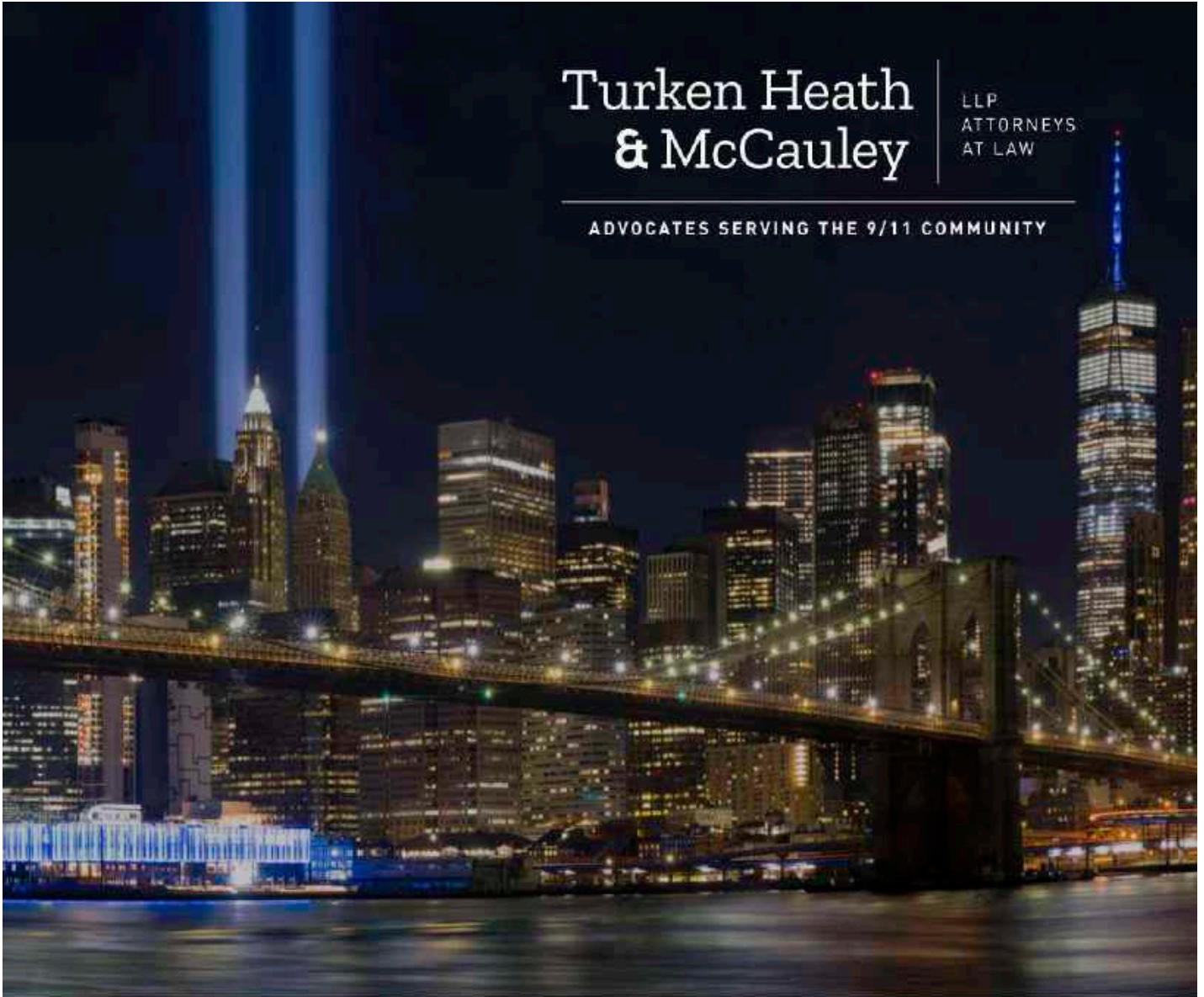
